Concept of Human Security

- People-centered, cross-cutting, comprehensive approach
- Active collaboration between governments, international organizations, NGOs, civil society and enterprises
- UNGA resolution adopted in September 2012
- Defined as people-centered, comprehensive, context-specific and prevention-oriented



The programme aimed to empower and protect victims of trafficking through provision of victim assistance.

UN Trust Fund for Human Security (UNTFHS)

- Established in 1999
- Promoting human security has been the main activities
- Japan being an instigator to establish the UNTFHS
- Since its establishment, 450 million dollars used into 243 projects across the world
